# Object, Dates and Scope

# Description and structure of the promotion

To participate in the promotion, interested internet users must access the webpage <a href="https://twitter.com/Rocky\_Bytes">https://twitter.com/Rocky\_Bytes</a>. After accessing the page, users must login to Twitter if they have not already done so, or create an account if they do not have one.

# Participants must:

- Become a follower of @Rocky\_Bytes if they are not one already by clicking on the "Follow" button.
- Search for the tweet announcing the draw and retweet it.
- Follow @Rocky\_Bytes for at least the duration of the promotion.

# Place and duration of the promotion
